

ARTICLE 23. SUMMER SESSION AND EXTENDED EDUCATION DIVISION INSTRUCTION

[For information only: Minima were derived for 2007 and 2008 by adding 2.5% to each of the minima for the previous year; for 2009, by adding 2.9% to each of the minima for the previous year.]

23.1 Summer Session 1 and 2 and ~~Intersession~~

23.1.1 A Member who in addition to his/her normal teaching assignment teaches in Summer Session 1 and 2 and ~~Intersession~~ shall receive a stipend of not less than the following per full course:

Year	<u>2008</u>	<u>2009</u>	<u>2010</u>
Stipend	\$7,444	\$7,630	\$7,851

The stipend for a course less than a full course shall be calculated on a pro rata basis. The actual amount of each stipend shall be determined administratively.

23.2 ~~Continuing~~ Extended Education Division

23.2.1 A Member who teaches in any of the business and professional non-degree career development programs, seminars or business courses administered by the ~~Continuing~~ Extended Education Division, except those noted in s. 23.1, s. 23.2.2 and s. 23.3, shall receive a stipend of not less than the following per class hour:

Effective September 1,	<u>2007</u>	<u>2008</u>	<u>2009</u>
Stipend	\$83.97	\$86.07	\$88.57

The actual amount of each stipend shall be determined administratively.

23.2.2 A Member who teaches in all other non-degree general interest programs, seminars or courses administered by the ~~Continuing~~ Extended Education Division, shall receive a stipend of not less than the following per class hour:

Effective September 1,	<u>2007</u>	<u>2008</u>	<u>2009</u>
Stipend	\$46.66	\$47.83	\$49.22

The actual amount of each stipend shall be determined administratively.

23.2.3 In the event that an offering in s.23.2.1 or s.23.2.2 is advertised and the number of enrollees times the fee to be paid by each enrollee is insufficient to cover the stipend required in s.23.2.1 or s.23.2.2, the University and the Member may agree to a reduction in the total stipend to no less than an amount equal to the number of enrollees times the fee paid by each enrollee.

23.3 Off-Campus University Credit Courses

23.3.1 A Member who teaches a university credit course at a location outside the Perimeter Highway shall receive a stipend of not less than the following per full course:

Stipend	\$7,444	\$7,630	\$7,851

The stipend for a course less than a full course shall be calculated on a pro rata basis. The actual amount of each stipend shall be determined administratively.

23.4 Obligations

Participation in ~~Interession~~, Summer Session 1 or 2, or ~~Continuing~~ Extended Education Division programs, seminars or courses which are not a part of the Member's regular teaching assignment shall not conflict or interfere with the fulfilment of the Member's primary duties to the University.

The Member shall obtain the approval of his/her dean/director, which approval shall not be unreasonably withheld, before accepting an offer to teach any program, seminar or course.

Teaching assignments in Summer Session 1 and 2, ~~Interession~~ or ~~Continuing~~ Extended Education Division programs, seminars or courses for which a stipend is paid shall be by mutual consent of the Member and the department head. Refusal to accept such assignments shall not prejudicially affect either party.
